EIGHTY-EIGHTH SESSION, 1934-35.

FIRST MEETING.

The Society met on 25th October, 1934, the President, Mr. Joseph Brennan, in the Chair Mr. H Steer Wood was formally elected a Member.

Mr James Meenan read a paper entitled "Some Aspects of the Italian Corporative Organisation" A vote of thanks to the reader of the paper was passed unanimously on the motion of Professor Duncan, seconded by Mr. Gallagher Senator Johnson, Mr. Steer Wood, Lieut.-Col Edgeworth, Mr. Dockrell, Mr. Hussey and the President also took part in the discussion
